2. Guidelines and disclaimer for people submitting events

Community Events Calendar Guidelines

The Calendar is open to the general public as a common place to post events that focus on watershed management topics.

Events posted on the Calendar should be located within the Province of Alberta, with preference given to events in the Red Deer River watershed. Events should be related to watershed management and other water or land related topics. Exceptions to this may be allowed at the discretion of The Red Deer River Watershed Alliance. All events must



be legal.

Events

All event postings will be reviewed and once approved, available to the public.

The Calendar is provided as a public service. The Red Deer River Watershed Alliance reserves the right to edit/exclude listings that do not meet the criteria outlined above.

Events must not promote the hatred or disrespect of any group and must not discriminate on any grounds covered by the Alberta Human Rights Act. In the event that The Red Deer River Watershed Alliance becomes aware of any violation of these principles, the posting will immediately be removed from the Calendar without notice.

The Red Deer River Watershed Alliance reserves the right to restrict or remove any content that is deemed to be in violation of these Guidelines or any applicable law.

Events should not:

- Imply that the Red Deer River Watershed Alliance is endorsing the event or any of the hosting partners, without written permission from the RDRWA;
- misrepresent its relationship with the RDRWA;
- present false information about RDRWA products or services;
- use the RDRWA logo without permission from RDRWA; and
- contain content that could be construed as distasteful, offensive or controversial.

Submitter Identification

Anonymous posting of events <u>are not</u> allowed. All public event submitters must be clearly identified by their event submissions. All event postings must be accompanied by valid event submitter contact information including a name, email address and phone number. This information is not publicly shared and is collected with the purpose of contacting the submitter about their event.

3. Terms of Use for people for people submitting events

I agree to indemnify, defend and hold the Red Deer River Watershed Alliance and its officials, employees, agents and representatives harmless from any liability, loss, claim and expense, including reasonable lawyer's fees, any of them suffers as a result of a breach of such representation or warranty.
